What FFT has Accomplished so far

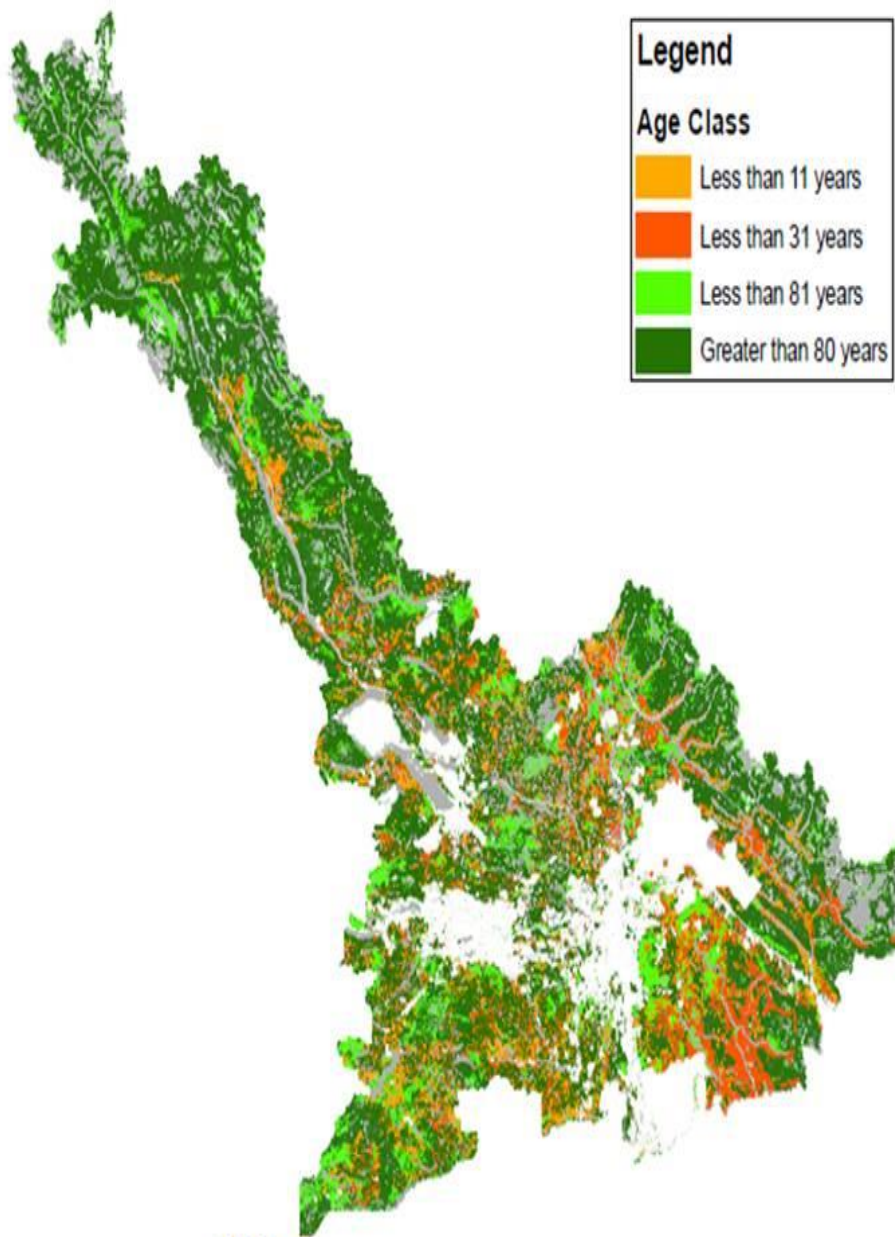


FFT Rehabilitated Forest Comprised

planting

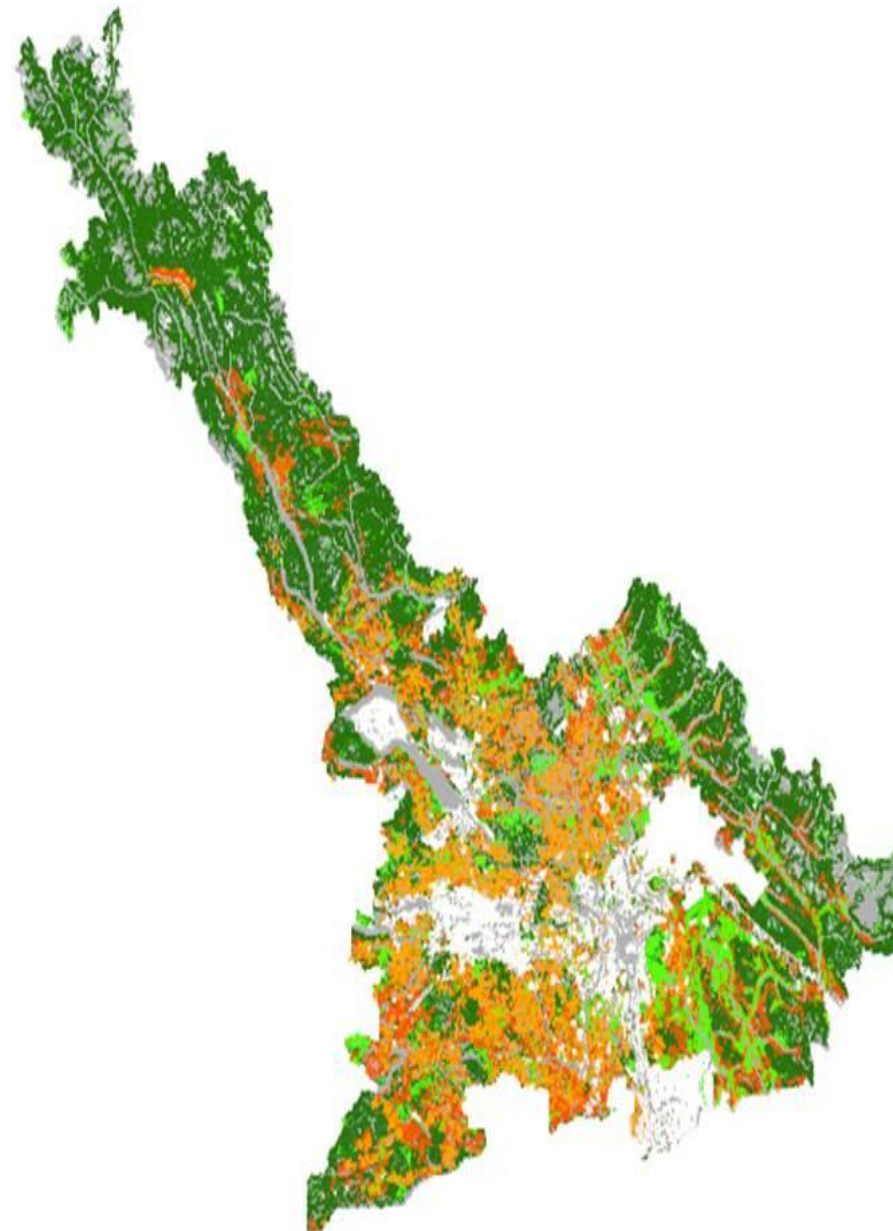
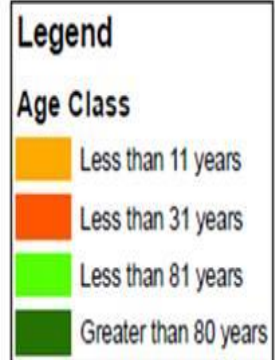

FFT and FESBC

- Understanding these will help us achieve success:
 - Where are the fire killed stands and dead pine?
 - Where is it merchantable, economic and feasible to harvest?
 - Where are the dead stands we will not be harvesting?
 - What does this look like? Is it wildlife habitat?
 - How well does it serve non-timber objectives now and in the future?

What do Restoration Opportunities look like?

- 
1. **Wildfire Rehab and restoration** >170,000 ha
 2. **MPB salvage and Replanting** > 250,000 ha
 3. **Fertilization** 30-40,000ha per year
 4. **Spacing** +/- 1,000ha per year

How does FFT and FCI work?

- Annual Operating Plan developed Sept - December
- Approximately \$1-2M per year for CFAs
- Process managed through the Association and PwC
- Focus right now on MPB rehab and wildfire restoration but spacing and fertilizing still important
