# Concerns Involving CFA's

Concerns involving Community Forest Tenures revolve around logging:

- visual quality impacts,
- recreation/tourism impacts,
- water impacts, and
- landslide risks.



# How Do We Help?

- Audits of community forests and commend good performance or help identify areas for continuous improvement
- Respond to citizens concerns or complaints, and provide information about forest & range practices and processes
- Act as a go-between to connect concerned citizens and forest & range licensees and/or government staff to address issues.
- Initiate special projects to focus provincial areas of improvement



# Reports Relevant To CFA's

Board reports and recommendations can address topics of interest to Community Forests:

- *Managing Forest Fuels in Wildland Urban Interface Areas* – recommendations for local governments to assist with fuel reduction and FireSmart efforts
- *Forest Stewardship Plans* – recommendations for public and stakeholder involvement in FSPs
- *Community Watersheds* – recommendations to manage watersheds that supply drinking water
- *Stewardship – A Forest Practices Board Perspective*



# SECIAL INVESTIGATION: Forest Stewardship Plans: Are They Meeting Expectations?

VICTORIA – An investigation of forest stewardship plans, the primary plan governing forest activities on public land, concludes that most of these plans do not meet the public's needs, are not enforceable by government.

“We are recommending that government not renew or approve any forest stewardship plans that don't meet the standards set out in the Forest and Range Practices Act,” said Ryan. “We also recommend that the public consultation process be improved and that professionals who prepare forest stewardship plans, and officials who approve them, are apprised of their responsibilities regarding these standards.”
