## **Key Takeaways**

- Collaboration is essential to address fibre flow, local manufacturing, and employment challenges.
- Grassroots initiatives like the Robson-North Thompson Coalition offer more flexibility and local relevance than top-down approaches.

- Regular communication (bi-weekly calls), a shared mission, and clear terms of reference have been foundational to coalition success.
- Indigenous partnerships, especially with Simpcw First Nation, bring valuable perspective, leadership, and trust.
- There is an urgent need to stabilize fibre supply and improve connectivity between small-scale producers and manufacturers.
- Regulatory support and funding programs are aligning to help support these initiatives, but consistent data and engagement are still lacking.

#### **Action Items**

- Finalize coalition's terms of reference and share among members (Clearwater, March 2025).
- Create an online fibre marketing platform and business directory to improve fibre flow visibility.
- Conduct grassroots-level surveys and engagement to understand the needs of small-scale mills.
- Support policy conversations on local processing and managing fibre gaps.
- Host pilot projects to test new models for local fibre allocation and manufacturer collaboration.

### **Questions & Follow-Ups**

- What is the percentage of value-added change over the past five years?
- How can we better survey and include small mills in provincial planning?
- What are effective mechanisms to ensure predictable fibre supply for new enterprises like biochar plants?
- How can government and BCTS better support local and Indigenous-led initiatives through policy?
- Who qualifies as part of the value-added sector and how do we ensure inclusion?

## My Thoughts/Observations

- There is clear momentum toward more community-based forestry management.
- Simpcw's involvement shifted the conversation toward inclusion and values-based decision making.
- Stabilizing local fibre flow is central to regional resilience and job creation.
- There's a growing sense of urgency about small and medium manufacturers being left behind.
- The initiative shows how collaboration between government, First Nations, and community forests can yield scalable, lasting solutions.

#### **Connections to Other Sessions**

- Ties closely with the "Sticky Situations" session on trust-building and community engagement.
- Echoes themes from sessions on fibre access, value-added strategy, and First Nations collaboration.
- Also connects with extension-related conversations (e.g., Fuel for Thought) and practical implementation of local solutions.
