



2022 BCCFA CONFERENCE & AGM October 19-21, 2022 Nakusp, BC

Conference Summary Report

Delegates gathered in Nakusp, BC from October 19-21st, 2022 to participate in the BCCFA's 20th Anniversary Conference & AGM. The Nakusp and Area Community Forest, our host for the event, went above and beyond to deliver a fantastic event.

On Tuesday, delegates had the opportunity to participate in pre-conference field trips featuring Kootenay innovation. Thank you to Kalesnikoff and SIFCo for offering tours of their spaces.

Throughout Wednesday morning we were treated to a field trip to NACFOR's operating area, which included stops at one of their fuel treatment areas, Box Lake Lumber, and a beautiful lakeside lunch hike.

On Wednesday afternoon delegates broke into groups and visited the Southern Mountain Central Selkirk Caribou maternity pen, or had the opportunity to work with Alan Simpson in a workshop on respectful negotiation, enhanced communication, and personal capacity building.

Our reception on Wednesday night was wonderfully attended and we enjoyed a fantastic presentation from the Arrow Lakes Historical Society on the history of logging in this area. We extend our gratitude to Richard Whitney from the Lakes People of the Colville Confederated Tribes for welcoming our delegates to gather on this traditional territory.

On Thursday morning our first session of the day highlighted the new provincial vision for forestry and how our community forests enhance and contribute to that vision. Thank you to Eamon O'Donoghue, Julie MacDougall and Doug Kelly for joining us this week to share their insights. We learned that a large focus of the work ahead will be moving from spatial management to dynamic, adaptive management of our landscapes.

Next, we were treated to a fascinating panel discussion on landscape level planning with moderator Garnet Mierau, Garry Merkel, Beth Eagles, Dave Gill and Erik Leslie. The community forest managers shared how they have been working under landscape plans for over 10 years, plans generated through deep engagement with the community with a long term lens.

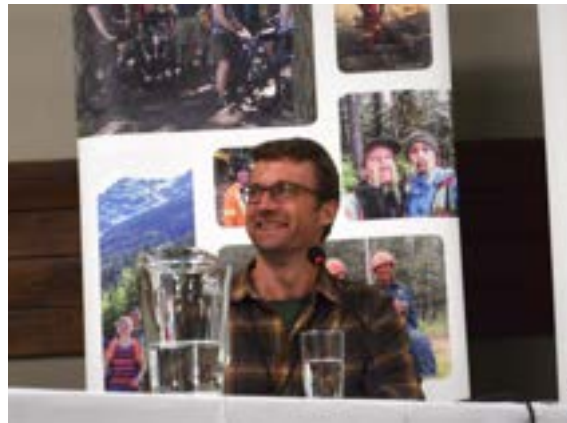

Key takeaways were that momentum for landscape level planning must be driven from the land. We must meet the people, the constituents, those who the plan is for - as we work to understand values, principles and priorities. This path ahead may come with its challenges, but will result in a more sustainable and resilient land, forest and future. Garry Merkel challenged the group to consider how timber supply needs to be driven by land and forest management decisions, and not vice versa.

Afterwards, Jeremy Shelford, a forester and lawyer with one of our sponsors - Ratcliff & Co., shared his expertise on the legal work that community forests may be faced with during their operations. We learned that legal aid is available to community forests for a range of topics including log sales agreements, board governance and regulatory work.

Thank you to our Keynote Speaker, Jason Fisher, who explained the fundamentals of forest carbon offsets.

For our afternoon session, BCCFA Executive Director Jennifer Gunter joined Steve Kozuki of FESBC, as well as Dr. Lori Daniels and her team Kelsey and Kea, for a discussion on adaptation for wildfire resilience. Through this session, moderated by Randy Spyksma, this message was reinforced - the time is now, and we must collectively do more on a provincial level to increase our wildfire mitigation efforts. As Lori stated, we are already awake - from the many fires of the past decade, we are all now aware of the urgency of our situation. We need the political will and increased support, advocacy and capacity to shift into a higher gear of action to protect our communities and landbase from catastrophic fire events. We learned that while community forests are leaders in this work, there is still much to be done.
